

Lewis and Clark Library Policies

LIBRARY CARD POLICY

POLICY: It is the policy of the Lewis and Clark Library Board of Trustees to issue library cards to eligible patrons.

PROCEDURES: Library cards will be issued free of charge to residents and taxpayers of Lewis and Clark County. Library cards are available for a fee to non-residents.

- **RESIDENT CARDS** – Photo identification and proof of residency in Lewis and Clark County is required prior to issuing a library card. MCA 1-1-215 states that an individual may only be "... a resident of one place and that would be the place where they live." Persons producing identification which proves residency in Lewis and Clark County will receive a library card free of charge.
- **NON-RESIDENT TAX BASED CARDS** - Persons residing outside of Lewis and Clark County but who pay property taxes to Lewis and Clark County may receive a library card free of charge. To obtain a non-resident, tax based card a patron presents a permanent, out-of-county photo identification, and staff will confirm the tax status in the Lewis & Clark County Property Tax Database. If the tax is paid in the name of a business or a corporation, confirmation of business or corporate ownership will also be required.
- **NON-RESIDENT CARDS** - Persons residing outside of Lewis and Clark County may purchase a library card for an annual fee of \$45. This card is valid for a period of one year and must be renewed and paid for annually. This card covers all household members residing at the same address (i.e. children, spouse). Persons wishing to purchase a non-resident card must provide the same identification and proof of permanent residency as residents of Lewis and Clark County.
- **TEMPORARY RESIDENT CARD** – Persons temporarily residing in Lewis and Clark County and residents of all temporary addresses, facilities and shelters in Lewis and Clark County are eligible for a free library card by completing an application and providing written proof of temporary residency (i.e. lease, receipt, an official letter from residence owner/organization), and a driver's license or photo ID.

The card is valid for 3 months from the date of issue and may be renewed so long as the individual continues to reside at a temporary address, facility or shelter, or reside temporarily in Lewis and Clark County. A limit of 5 (five) items may be checked out at any one time. Some limitations may apply.

The fees and policies for non-resident cards will be set by the Lewis and Clark Library Board and will be subject to change at the discretion of the Lewis and Clark Library Board of Trustees.
